## ***'Smart' Meter Rollout in Light of Insights on Radiant Electricity from Rudolf Steiner***

It is important that we all be aware that a new surge in radio-frequency, RF, radiation is about to sweep into our region in January 2024. 'Smart' electric meters are about to be rolled out by our utility company, to replace our health-safe, cyber-safe, fire-safe, privacy-protecting mechanical-analog meters. The analog meters have the flat, spinning disk. Some account holders might have digital meters, but these will also be switched to wireless RF radiating 'smart' meters. These new meters will have FCC ID numbers on them, since they will emit RF transmissions (*it is not advised to be near them*). The ID means this federal agency regulates them to prevent interference between users of RF spectrum frequencies. However, this agency does not concern itself with protecting the biological processes of every living being from interference from these RF radiations. There is a mountain of evidence of harm from wireless radiation. Do see the talks at the EMF Medical Conference 2021 on these biological effects.

During the *Agriculture Course* that Rudolf Steiner gave in Koberwitz, in the June 16, 1924 discussion period, he was asked about the use of electricity for conservation of fodder. He remarked that "a better gift of observation" on this matter seemed to be coming out of America as compared to Europe at that time. Concern was voiced "to the effect that human beings cannot go on developing in the same way in an atmosphere permeated on all sides by electric currents and radiations. It has an influence on the whole development of the human being." On all sides? – that is us now and growing ever worse! He went on to say:

This is quite true; the human being's inner life will become different if these things are carried as far as is now intended. It makes a difference whether you simply supply a certain district with steam-engines or electrify the railway lines. Steam

works more consciously, whereas electricity has an appallingly unconscious influence; people simply do not know where certain things are coming from. Without a doubt, there is a trend of evolution in the following direction. Consider how electricity is now being used about the earth as radiant and as conducted electricity, to carry the news as quickly as possible from one place to another. This life of human beings in the midst of electricity, notably radiant electricity [wireless telegraphy, now cell phones and towers, routers, wireless devices] will presently affect them in such a way that they will no longer be able to understand the news which they receive so rapidly. The effect is to damp down their intelligence.

He also said that

You must know that electricity is at a lower level than that of living things. Whatever is alive – the higher it is, the more it will tend to ward off electricity. It is a definitely repulsion. If now you train a living thing to use its means of defence where there is nothing for it to ward off, the living creature will thereby become nervous or fidgety, and eventually sclerotic.

When we read "nervous or fidgety," isn't this what we see in the ever-rising prevalence of ADD, ADHD and autism spectrum disorders nowadays? There is an important article, published in 2017, "The Emerging Link Between Wireless and Autism," which is accompanied by references on the known biological mechanisms through which these developmental problems arise when triggered by wireless radiations. Please may we all take this short article to heart and into our will. I would say that nay-sayers either do not understand these mechanisms or they ignore this substantial body of science.

I urge taking *precautionary* action regarding the 'smart' meters: immediately call the electric company to place an order to keep your existing mechanical-analog meter. (In the case of digital meters, which create harmful dirty electricity frequencies, firmly request an analog meter.) After opting-out of the 'smart' meter, place a notice on the existing meter to be sure that the technician *knows*. Even send a written letter, to put it on record again. You will be charged \$13.47 monthly. But know that your bill will increase with a 'smart' meter, too: the electricity it uses for computation and for transmitting your private usage data at frequent intervals daily is charged to you – something an analog meter has no need to do!
